**SECTION 4. First aid measures****4.1. Description of first aid measures**

During the risk assessment process, it is essential to take into consideration the ACGIH occupational exposure levels for particulate not otherwise classified (PNOC respirable fraction: 3 mg/m<sup>3</sup>; PNOC inhalable fraction: 10 mg/m<sup>3</sup>). **8.2. Exposure controls**
